<p>Public Comments:</p> <ul style="list-style-type: none"> • Mike Karaskas: Discussed Sapphire Plat 1. He would like to propose a revision to the Plat. He stated that the Plat map shows that his property goes all the way to the beach. He would like to see the hill to the lake added into the Plat, thus making no changes to any easements or the beach. He claimed that the property owners are willing to pay for the revisions, this hill area is unusable to anyone else, the township could then increase the property owner taxes, and currently he feels that this hill area is a liability to the township due to Oak Trees & Oak wilt. According to his estimates there are 25-26 lake front owners and 92 lots front and back. TABLED. • John Beck: Accepted plat dedications back in 1976. He has documentation showing that he used to be taxed on his boathouse at the bottom of the hill. Requested that the Township hire someone that is experienced in lake law to move further with Mr. Karaskas request. • Bonnie Baird: Brought in samples of glass and metal found at Elm Street. Stated that this particular area used to be a dump site and is full of excessive hazardous material. She owns property on both sides of Elm Street and doesn't want this to be a public swimming area. doesn't want to see the area improved, its overgrown, doesn't want people parking there. She recently spoke to Sue Conradson who is giving Bonnie a permit to dig out 125ft. of shore. This will either be sifted on site with the hazardous materials being removed, or will be trailered out. Bonnie said that Sue won't allow Elm Street to be approved for a beach or a park because it is a wetland. Bonnie stressed that there is no security, no supervision, no patrol, you can't see the area from the road and it is too narrow for two vehicles.

- Matt Gunnerson: If you can't see the area from the road, the township should remove all of the trees.
- John Beck: Stated that the Lake Enhancement committee discussed a walking path using the right of way to Crooked Lake.

The Missaukee County Road Commission wants to vacate Elm Street. Ouwinga makes a **MOTION** to pursue the Jennings Beach area spending up to \$5000.00 to clear out trees for a better visual of the beach. - Bonnie Baird: Since the board is moving forward with the beach area, she requested signs of no fishing, and no one allowed without parental vision under the age of 12. Then stated her search of registered sex offenders in the area and in Missaukee County.
- John Beck: Presented the board with minutes from the August 11, 2018 Lake Enhancement Committee meeting. Items discussed were: power washer at Green Road launch, fish structures working, spring newsletter, swimmers itch, purple loosestrife, Jennings swim area, Landing Blitz publicity, and a lake map for Sapphire. Request made for the funding of 3 people to attend the Michigan Inland Lakes Conference in Grand Rapids, Oct 3-5. **MOTION** by Ouwinga, seconded by Wolford to approve the funds of \$944.00 for the Michigan Inland Lakes Conference.
