<p>Public Comments:</p> <ul style="list-style-type: none"> • Don Nemecek- Concerned about hooking into the sewer system for Crooked Lake. Questioned rules about hooking into the existing sewer system. Health department shouldn't issue permits without hooking into the line. Approximate cost is \$12,000.00. Suggested to hook the sewer from the park to Anderson Trail. Wanted us to think about a sewer before a park. Stated that the purchase of the Jennings house on Walnut street was not in the Missaukee Sentinel, only in the Cadillac News. A resident from the crowd stated that the article about the purchase of the house was in both papers. Later stated that he thinks the board should not move forward with the park project in Jennings without the sewer system project for the lake residents included in that plan. • Mike Stimak- wants the sewer system extended past the boat launch due to concerns of RV's that pull into the vacant lots past the boat launch. Later asked if there would be something on the website about the park project. Would like to see the possibility of a list of plans and stages of how we got to this point and where we will go to from here. Links to the information would be great. • Josh Fairbrother- discussed the Owl system, stated that he found a different company to purchase the equipment through. Suggested returning the equipment to amazon and moving forward with the new company because they offered a three year warranty and tech support, which amazon did not. The board agreed that a three year warranty and tech support would be beneficial. The board agreed to return the original equipment to amazon and re-purchase the same equipment through Fairbrother Aerial Solutions who worked out the 	<p style="text-align: center;">PUBLIC COMMENTS</p>

There would be no fees added for Fairbrother Aerial Solutions to purchase the new equipment on behalf of the township.</p> <ul style="list-style-type: none"> • Pam Hill- Doesn't want to see residents of Jennings mooring boats on the swim dock, or possibly a new dock that may be installed at the Helmer Park location. Supervisor Hall stated that boats would just moor in the water. Looking into the possibility of permitting those boats so that the township would have control over the amount of boats in the water. Discussed the possibility of having a handicap platform for fishing access at the park. Suggested handicap parking spots to be located near a pavilion area. Discussed applying for a grant for the park improvements. Supervisor Hall stated that Prein & Newhoff could write the grant for approximately \$4,000-\$6,000.00. • Becky Stimak- Concerned about the health of the lake by adding a park and having boats moor. Asked if there were still spots available on the Helmer Park committee. Concerned about new development. Worried about gas spilling into the lake. Overpopulation on the lake is a concern of hers. Went through a lot with road sloping on Oak Drive & permits. • Joanne Kelly- Stated that she has a major concern with the stipulations put in place for the Air B&B's. She feels that the new rules are trying to push people out of town. She reviews each one of her guests with no problems or police called. If they are not good renters, they don't rent to them again. Supervisor Hall stated that the new rules were put in place by the Mayor at the city and Lake Township has no control over that. • Bonnie Baird- How much money can the board spend out of the General Fund before they need to have a public hearing? How much has been spent out of the General Fund for this park?

Al reported to the advisory committee that four aerators were purchased from D&D. Had an issue at Duck Point, had C&W pump. Pump #3 went down on Lakeview Drive and needed to use the vac truck out of Cadillac. Al is staying on his wife's insurance Kate Cobb working on Michigan Works/apprentice program for sewer assistant. Al requested life insurance, Trustee Bradley waiting on quote. Bradley getting an estimate on sewer at the park extended to Poplar street. Lake Street foreclosed property had a sewer usage balance of \$483.42. County Treasurer stated that Lake Township is out that money because it cannot be added to the sale.
